23/24.49 Apologies and declarations of Interest

23/24.50 Public Session

Residents raised their concerns in relation to the planning application TWC/2023/0772 which there has been a number of inaccuracies in this application which do not correspond with what has actually been erected as part of this proposal. Residents are upset that the initial approach by the landowner, to some neighbouring properties suggested a much smaller proposal to the sizable proposal that has been applied for and will have significant noise effects on neighbouring properties and the wider community.
